Spokane Hamfest Information

As you might have guessed a lot has been going on since the starting of discussions on a Hamfest in the Spokane area. Your President KA7SUZ was asked to approach a couple of the local Spokane Ham clubs with information regarding this event. The following was part of a presentation to these clubs;

"Good evening - guess everyone knows I am, KA7SUZ, President of the Kamiak Butte Amateur Repeater Association. Recently I was approached about having KBARA be the 'overseeing' group for a Hamfest this year. After discussing it with my board, we took a poll on our regular Wednesday evening net and got strong support of the idea. It seems important to draw a definite line between what is a 'local Amateur Radio Operator Supported Hamfest' and what is not so supported. Last year people got hurt and people are still angry. We need to regroup and put on a fun, club sponsored Hamfest 'Like the good-old-days'. If we don't, will this close a window of opportunity?"

I have told your board that I have only two points that I insist on. 1) This Club Sponsored Hamfest in NOT to be considered or suspected of being an attempt to bash anyone. Warren Kelsey is doing his event, and we are doing ours. Negative remarks do not belong in any discussions pertaining to our Hamfest. We are simply saying, when necessary, that there is a privately run Hamfest in the Spring and one in August being put on by the area clubs and their members. PERIOD. 2) That the treasurer, or another member so designated, from each club with a monetary investment in our Hamfest be a member of a Finance Committee. This committee will oversee the management of the money, and collect the pre-registration money. They should meet periodically to monitor the movement of the funds. Within a week of the closing of the Hamfest, that

group should have met, audited the prepared report and reassure their respective clubs. I know there are lots of question. At a financial meeting held here in Spokane for the event was a variety of supporting clubs and individuals. Representatives from Spokane Radio Amateurs Club, Inland Empire VHF Club, The North West Tri-State ARO, The Kootenai Amateur Radio Society from Idaho, and of course KBARA were all present to ask questions and give ideas in support. A site has been selected and arranged for. The Flyer is in the works and people are already asking for them for trips to other events so that they can pass them out. All in all, the Inland Northwest is 'Buzzing' with excitement over this Hamfest. More information will follow as it becomes available.

This was passed on to me from one of my dearest OM friends so I thought I would share it with you.

THE CARE AND FEEDING OF YOUR PET HAM
BY LAURA SARGENT.

THE PET HAM IS ONE OF THE MOST INTELLIGENT OF PETS. OFTEN SEEMING ALMOST HUMAN. BUT HE CAN ALSO BE ONE OF THE MOST DIFFICULT TO KEEP. ONLY A PERSON WITH A GREAT DEAL OF PATIENCE AND UNDERSTANDING SHOULD ATTEMPT TO KEEP A PET HAM.

THE FOLLOWING IS A SHORT GUIDE TO SOME OF THE MOST IMPORTANT THINGS THAT YOU SHOULD KNOW ABOUT CARING FOR YOUR PET HAM.

1. LIVING AREA: YOUR PET HAM SHOULD HAVE A PRIVATE AREA OF HIS OWN, AN ENTIRE ROOM, IF POSSIBLE. WHERE HE WILL NOT BE DISTURBED. HE

WILL SPEND MANY HAPPY HOURS ALONE THERE WITH HIS COLLECTION OF TREASURES. (BOXES, WIRES, BITS OF METAL, GLASS, PAPER, PLASTIC, ETC. THAT HE WILL BRING HOME REGULARLY). HE SHOULD BE ENCOURAGED TO CONFINE HIS ACTIVITIES TO THIS NEST ROOM IN ORDER TO PROTECT THE REST OF THE HOUSE FROM HIS NATURAL TENDENCIES TOWARD NOISE, CLUTTER AND MAKING HOLES IN THE WALLS...

2. EXPENSES: RAISING YOUR PET HAM CAN TURN INTO AN EXPENSIVE HOBBY. BUT, UNLIKE MOST PETS, THE PET HAM CAN BE TRAINED TO WORK OUTSIDE THE HOME FOR SHORT PERIODS AND SO BRING IN ENOUGH MONEY TO COVER PART OR ALL OF HIS EXPENSES...

3. FEEDING: THE WELL BEHAVED PET HAM WILL BE ABLE TO EAT WITH THE FAMILY ON OCCASION. BUT HE USUALLY FEELS MORE COMFORTABLE AND SECURE IF HE CAN TAKE MANY OF HIS MEALS IN THE PRIVACY OF HIS NEST ROOM. IT WILL BE YOUR RESPONSIBILITY TO SEE THAT YOUR PET HAM IS KEPT WELL SUPPLIED WITH FOOD AND DRINKS DURING THE LONG PERIODS OF TIME THAT HE WILL SPEND ALONE IN THE NEST ROOM...

4. HOUSEKEEPING: PET HAMS CAN USUALLY BE TRAINED TO USE THE FAMILY BATHROOM FACILITIES...

5. OBEDIENCE TRAINING: MOST PET HAMS CAN BE TRAINED TO RESPOND TO A FEW SIMPLE COMMANDS... THE EASIEST FOR HIM BEING SIT AND SPEAK. ONCE YOUR PET HAM HAS LEARNED THESE COMMANDS, HE WILL SOMETIMES PRACTICE THEM ON HIS OWN FOR HOURS AT A TIME...

6. HEALTH CARE: THE PET HAM IS ESPECIALLY SUBJECT TO MINOR IRRITATIONS OF THE LOWER BACK AND SORE THROAT FROM TOO MUCH SITTING AND SPEAKING. THE SPECIAL CW BREED TENDS TO HAVE A TIRED WRIST RATHER THAN SORE THROAT, AND THE RTTY VERSIONS MAY SUFFER FROM TIRED AND HURTING EYES DEPENDING ON HIS AGE AND MONITOR...

7. TRAVELLING: YOUR PET HAM WILL GLADLY TRAVEL WITH YOU IN THE FAMILY CAR IF HE IS ALLOWED TO BRING SOME OF THE COLLECTION FROM HIS NEST ROOM. HIS FAVORITE TRIPS WILL BE TO PLACES WHERE HE CAN ASSOCIATE WITH OTHER PET HAMS FROM OTHER FAMILIES...

8. BREEDING: IF YOU PLAN TO BREED YOUR PET HAM, YOU SHOULD DO SO AS EARLY AS POSSIBLE AFTER YOU GET HIM... AS THE PET HAM MATURES HE BECOMES MORE AND MORE RELUCTANT TO ENGAGE IN ANY ACTIVITIES NOT CONNECTED WITH HIS NEST ROOM COLLECTION...

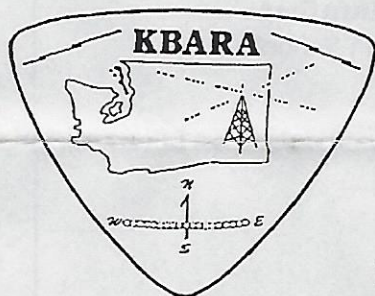

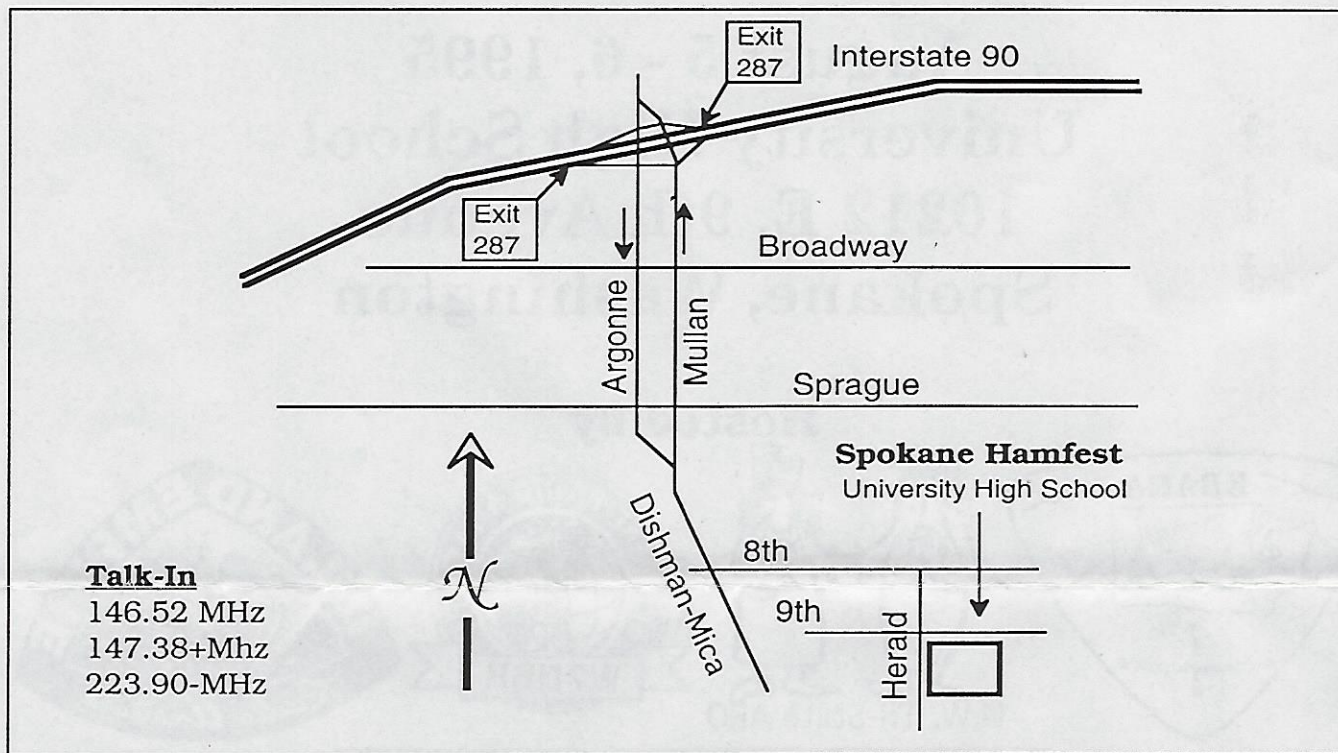

A SAD STORY

I am writing in response to your request for additional information for block #3 of the accident reporting form. I put "poor planning" as the cause for my accident. Your letter said I should explain more fully, and I trust the following will be sufficient.

I am an amateur radio operator and on the day of the accident I was working alone at the top of my 80 foot tower. When I had completed my work I discovered I had, over the course of several trips to the top of the tower, brought up about 300 pounds of tools and hardware. Rather than carry the now un-needed tools and materials down by hand, I decided to lower the items down from the top of the tower in a small barrel by using a pulley which was fortunately attached to the top of the tower.

Securing the rope at ground level, I went to the top of the tower and loaded the tools and the materials into the barrel. I went back down to the ground and untied the rope, holding it tightly to insure a slow decent of the 300 pounds. You will note in block #11 of the accident reporting form that I weigh only 155 pounds.

Surprised at being jerked off the ground so suddenly, I lost my presence of mind and forgot to let go of the rope. Needless to say, I proceeded at a rather rapid rate of speed up the side of the tower. In the vicinity of the 40 foot level, I met the barrel coming down. This explains my fractured skull and broken collarbone.

Slowed only slightly, I continued my rapid ascent, not stopping until the fingers on my right hand were two knuckles deep into the pulley.

Fortunately, by this time, I had regained my presence of mind and was able to hold onto the rope in spite of the pain. At approximately the same time, however, the barrel of tools hit the ground and the bottom fell out of the barrel. Devoid of the weight, the barrel was approximately 20 pounds. I refer you again to my weight in block #11. As you can imagine, I began a rapid decent down the tower. In the vicinity of the 40 foot level, I met the barrel on its way up. This accounts for the fractured ankles and the lacerations on my legs and lower body.

The encounter slowed me enough to lessen my

injuries when I fell onto the pile of tools and fortunately only 3 vertebrae were cracked. I'm sorry to report, however, that as I lay there on the tools, in pain, unable to stand, and watching the empty barrel 80 feet above me, I again lost my presence of mind. I let go of the rope.

ELECTRONIC FILING UPDATE

We have an update on the status of electronic filing of license applications. According to ARRL VEC Administrator Bart Jhanke, KB9NM tells us that Newsline #909 has an incomplete quote regarding the ARRL VEC's handling of electronic Form 610 application filing.

Bart says that the complete information is that, regardless of whether a VE team enters application data and mails or Electronically mails that data to the ARRL VEC, he must still receive the actual hardcopy Form 610 applications and hardcopies of other pertinent test session documents, and must screen them, before he can forward the successful applicant data electronically to the FCC. Bart emphasizes that the ARRL cannot simply bounce data received from a VE team to the FCC without screening the exam documents first.

KB1NM also says that electronic filing is now very alive and well for two of the 18 VEC's. Five more VEC's will be coming on board in the near future.
