# THE WINTER OF 1992 NOT KIND TO K.B.A.RA. REPEATERS

The '38 repeater was plagued with a multitude of ailments this winter to include a total failure of all those little bits and pieces crammed into the tin box. For a time a substitute repeater was functioning out of Art's store operating simplex on 147.38.

This repeater is back in full operation on the hill as of March 31st.

The Kamiak Butte and Walla Walla repeaters were not immune from incidents this winter either. Strange noises and untimely mysterious outages plagued these machines periodically. Here again pray for warm weather as our repeater techs want to get up on mountain tops to fix things.

Art is planning on adding more "winter proofing" to the system this summer so perhaps we will not be as vulnerable next winter.

#### Repeater Decorum

During a recent meeting of the Inland Empire VHF Club Jim WB7AVD pointed out that there is quite a bit of abuse of privately owned repeaters and FCC violations involving all repeaters within our area. Jim suggested permission be obtained prior to using a private repeater other than for emergencies. Observance of this together with respect for the private repeater operator will allow these repeaters to continue to be open and not closed repeaters. Drive into California some time and try to use a "closed" repeater. If it can be accessed without a tone you will be asked in no uncertain terms to leave the frequency if the call is not a real emergency.

Most of the offences Jim mentioned include messages and/or conversations related to commercial activities. Such an activity might include ordering a pizza on the autopatch which is definitely a NO-NO even if you leave off the anchovies.

Within our area we now have two OO's and they do monitor all area repeaters periodically for this type of activity. Fortunately, the KBARA system is not plagued with too much activity involving items of a commercial nature. ATTA-BOY control ops. Due to the long distances involved, we desperately need more radio technicians to help keep the system running.

An Omak radio club wishes to link to our Stensgar site, however, they have no interest in connecting their system directly to Seattle. A Montana group, represented by John-KA5LXG, has expressed interest in obtaining a group membership to K.B.A.R.A.

# **AUTOPATCH AND REPEATERS**

#### K.B.A.R.A. REPEATERS USER INFORMATION

KBARA operates five repeaters which are located in Pullman (146.74), Walla Walla (147.28), Spokane (147.36 & 147.38) and on Lookout pass (147.02) which is on the Idaho - Montana border. The 146.38 and the 147.02 repeaters are normally linked into the Evergreen innertie through the Nanum Ridge machine into Seattle and other areas. The other three repeaters are linked together and can be tied into the Evergreen innertie under the direction of one of the control operators. The '36, '74 and '28 machines are equipped with an autopatch and emergency autodial phone numbers. Use of the autopatch is restricted to emergency, priority and health and welfare calls.

#### TO ACCESS THE AUTOPATCH:

- 1. IDENTIFY YOUR STATION.
- 2. Access the patch by pressing \*(star) 123 on your
- DTMF touch-tone pad. Expect a dial tone.
  - 3. When you hear the dial tone, dial your number.

#### TO CLEAR THE AUTOPATCH:

1. Press # (pound) 123. There will be a tone confirmation when the patch isterminated/disconnected.

#### 2. IDENTIFY YOUR STATION.

IDENTIFY YOUR STATION PLEASE!

There is NO general 911. When placing an emergency call to any of the above speed-dial numbers, it is generally a good idea to tell the answering person you are a mobile radio rather than a ham. This often eliminates or minimizes clarifying questions by the dispatcher. Be prepared to give your location (use highway numbers and mile post numbers), the nature of the emergency, any injuries and what lane or direction of travel if a vehicle is involved.
