# Minutes of the 46th annual meeting of KBARA

V.: 3.2

13:20 **Meeting called to order** by Jim Ashleman (N7WRR) followed by the KBARA member and associates in attendance. There was a mix of **17 members and non-members** present.

13:28 **Last year's minutes** read to all in attendance by Tim (N6JXN)

13:29 Last year's minutes were voted on and accepted by the members of KBARA

13:29 **Treasurers report** was read by Betsy (N7WRQ) from 1 July 2023 thru 30 June 24 and was as followed:

The club's membership was 85 members;

With a bank balance of \$8,427.65;

There was a revenue totaling \$2,420.00;

With expenses **\$1,822.69**;

Membership was \$845.00 with extra donations of \$1,575.00.

13:32 **The Treasurers' report** voted on and approved by the members present.

13:33 An **informal remembrance** for both Harry (W7HEE) and Guy (VA7GV) was presented by Jim (N7WRR).

## 13:35 Old Business

Spokane Ham Fest: 2022 was the last time the Spokane Ham Fest was put on. Last year's event was cancelled due to conflict needs by University High School over lapping 2022 Ham Fest date. The school multipurpose room needed to be reserved during the early part of June 2024 but there was a failure of communication leading a loose in the reservation for the room. The cost to the club would have been for cleaning fees and not necessarily for the room itself. This made that economically advantageous compared to other commercial venues that would have cost much more. Seed money of \$500 USD used to initiate the Ham Fest would potential be recovered by using the High School site. However, the philosophy of the Ham Fest is not to make additional funds off the event but to bring the Ham community together in celebration of the hobby.

**Sec op Note**: A further round table brain storm about future Ham Fest sites were discussed such as exploring the use of either Clayton and/or Rockford fairground sites for next years event. Rob (KK7NND) offered to help Betsy (N7WRQ) locating a future

### 13:42 New Business

Jim (N7WRR) presented a report on his activities pertaining to Lookout Pass repeater. He stated that he swapped out repeaters at Lookout Pass. However, this repeater/duplexer combination still requires tweaking for proper operations. He also noted that the Look Out site duplexer is out tune. The transmitter put out 30 watts into the duplexer but the duplexer show only 13 watts output. The duplexer model is a TKR-750 designate. 13:43 Mica Repeater - A 6 port controller that was recently purchased and on hand is being worked on at present (25 pin connect require patients to correctly make the solder connections). Moreover, the controller will requires programing. The 4-port controller, presently located at Mica, will be used for Stensgar (147.360mhz) as a 3-port system due to port 4 not functioning.

**Sec op note:** A discussion by Jim N7WRR was held about the people who use to help out with various repeaters in the south region of the KBARA system. The discussion ranged from Pikes Peak repeater to the coverage of West Winds repeater. West Winds repeater over deviates the incoming signal requiring participants to back away from their microphones to reduce over deviation during signal processing. Attention was turned on to the northern repeat - Stensgar. It was noted that Stensgar is in a bad 'RF' environment requiring filtering of signals to avoid intermod interference.

**Sec op note:** Ed (KK7SAB) asked about emergency communication across the repeater system. His information request included whether KBARA had an Emcomm Liaison between ARES/RACES or any other emergency groups and whether he can serve as an Emcomm Liaison on behalf of KBARA. Jim (N7WRR) who is most familiar with this topic gave a thumb nail sketched on the KBARA system linkage. KBARA repeater system plays host to several groups that practice emergency voice skills: One on Sunday evening and the other on Monday evening. However, the club does not have a formal committee for Emcomm activity. If the club enacts an Emcomm Liaison, then according to the KBARA By-Laws an officer of the club needs to appointed that person to that committee. This matter was left un-resolved.

### 14:03 Nomination for Directors and Officers

Prior to nominating or voting - Jim (N7WRR) extolled the virtues why we need to rotate club members through the various positions of club's leader ship roles.

Scott (KF7VV) agreed to remain in his present position as Director for another 3 year term. Jim Gladden (KK7EW) and Edward Parry (KK7SAB) were nominated for the office of Vice President (V.P.).



Dennis Roberts KF7UTH became a silent key September 29th 2024 at 81 years old. He is known to many as the long time Thursday morning net control operator who was always there! He was a great supporter of KBARA and was the President of KBARA for several vears at one time. His church requested he obtain a ham radio license for emergency communications. He did and shortly after started as a net control for KBARA. He had a great radio voice, and was a good and dedicated net control for over 10 years. Many will remember his descriptions of growing up in the Ballard district of Seattle, his parents' relocation to Spokane, his military service in Korea, working undercover in the Silver Valley for Pinkerton, and his work as a tax auditor for the State of Washington. He was a very straight forward and honest person and we miss hearing and seeing him.

Many people have made comments and recalled Dennis on the nets since his passing. Included here as some sent in comments.

I used to kid him about investing in gold in which I'm involved and he disagreed with it as an investment. It was always good natured. He was a straight up guy with no pretenses. He will be missed by many.

# **Technical Update**

Most of the system is working fairly well at this time but work remains to be done. We still have the long tail on the 147.38 repeater at Mica caused by traffic coming in from the hub at Stensgar.

Mica Peak 147.38 repeater. The link to the hub from Mica was cutting out. I went to site on July 23<sup>rd</sup> and changed the 220 MHz radio that links to the hub. The SWR was good at 1.1:1 for the antenna system. Also did some programming of the controller. The link has been working fine since, but we still have the long tail at Mica. In July a new controller was ordered for Mica. It has been received and I have made up new cables for it and have been programing it. It is more difficult to program then the old one. I will try to get it installed over the next month. We designed an ice shield for the 220 MHz antenna and Glen K1RR is near completion building it and we will install it to try to prevent the winter outages we have had from damage to the antenna by falling ice. The photo shows the pole with the 5 element 220 MHz hub antenna; the ice shield will go just above it.



**Lookout Pass, MT 147.02 repeater.** In late August received reports that the Lookout repeater was down. I went to site August 25<sup>th</sup> and found the Kenwood repeater had blown finals; it was putting out much less then 1 watt. I replaced it with an ICOM FR-5000 repeater I had on hand and it is working, but I need to go back to adjust the controller; the local audio is a little over driven and not good quality. The antenna system is fine, with a 1:1 SWR, however found that we have 26.6 watts out of the radio, but only 17.4 watts out of the duplexer, this is a 1.8db loss and a little high, but considered acceptable. Will try to get someone with a service monitor to site next summer to see if we can do a little better and set the audio levels.

**West Twin, ID 147.32 repeater**. Scott KA7FVV and Glen K1RR are working on a new IRLP interface for West Twin. Currently it needs resetting daily and the audio going out over the link is too "hot" and distorted. We would like to get the new IRLP interface to site before it gets snowed in, but that is dependent on scheduling with the site owner and others. When we do get to site we will check propagation to the hub and if good, measure for coax and antenna and try to get permission for having a link radio in addition to the IRLP link at site for future use. We can use the old Mica controller for it.

Remember to check into the weekly KBARA Wednesday evening nets at 7pm for more information on the status of the system and with any questions you may have regarding the system or questions in general regarding amateur radio. We will try to get you answers.

223.900 MHz KB7ARA hub repeater on Stensgar (Stranger) Mt. near Chewelah, WA, owned by KBARA
444.350 MHz N1NG (192.8 tone) on Mica Peak near Spokane, WA, owned by Mike N1NG
IRLP Node #3638 in Spokane WA owned by Glen, K1RR
